All entrants must read and complete the reverse side of this form.

I/WE AGREE TO THE FOLLOWING:

1. Children under the age of 18 in the parade must be supervised by a parent or guardian.
2. Any individuals who operate a truck, car, tractor or any other motorized vehicle in the parade **must** possess a valid driver's license.
3. All vehicles and drivers must be insured including public liability coverage; a copy of the insurance must be submitted to the Fourth of July Committee.
4. High-performance vehicles (race cars, etc) must be towed or carried on a trailer; engines of such vehicles may **NOT** be started or operated during the parade.
5. NO motorcycles are allowed in the parade.
6. NO horses or other animals are allowed in the parade; EXCEPT for dogs on leashes.
7. The Sierra Madre Fourth of July Committee reserves the right to limit the number/type of vehicles and other entries in the parade.
8. All participants are expected to abide by general behavior guidelines. **Note: the throwing of candy and other objects is strictly prohibited.**
9. The Sierra Madre Fourth of July Committee does not endorse the views, representations, and behaviors of parade participants.
10. I recognize that participation in water play at the end of the parade is voluntary and there are inherent dangers in water play. I expressly waive any claim I may have against any person due to my voluntary participation in water play. Further, I hereby agree that I will not engage in water play with any individual who does not similarly indicate an intent, and willing participation, in water play.

WATER NOTIFICATION:

For the safety of the parade participants and spectators, **NO WATER** will be allowed during the parade. Water is allowed **only after the end of parade in front of Sierra Vista Park.**

ALL members in your parade entry must agree to the above rules as well as the Release of Waiver and Assumption of Risk by signing their name(s) below or on the attached Signature Form. If participants are minors, a parent must sign.

RELEASE OF WAIVER AND ASSUMPTION OF RISK: ALL parade participants MUST sign below or on attached form.

In consideration of the Department's acceptance of said participants application for participation in such "activity," I, for myself, my heirs, executors, administrators, and assigns, hereby waive, release and discharge the Sierra Madre Community & Personnel Services Department ("Department"), the City of Sierra Madre ("City"), and their officers, agents, employees, and volunteers and all sponsors and other entities and individuals associated with such "activities" ("release") from any and all claims for damages, for death, or personal injury which I or said minor may have or which may hereinafter accrue to said minor and/or me, as a result of my said or minor's participation in this "activity," and I further agree to indemnify and hold harmless from any liability or claim or action for damages which in any way arises out of my or said minor's participation in this "activity," even though that liability may arise out of negligence or carelessness on the part of any of the releases. I further understand that accidents may occur during such activities and that participants in such activity may sustain personal injuries as a consequence. Thereof, knowing the risks of such "activities," I hereby agree to assume those risks and to release and hold harmless the "releases" from any liability to me or said minor or our heirs or assigns for damages arising out of or related to my or said minor's participation in such activity.
