  - a) **ADOPTION OF RESOLUTION NO. 11-14 OF THE CITY COUNCIL OF THE CITY OF SIERRA MADRE APPROVING CERTAIN DEMANDS**

Recommendation that the City Council approve Resolution No. 11-14 for payment of City Warrants in aggregate amount of \$150,393.55; Sierra Madre Library warrants in the aggregate amount of \$3,809.65 and Payroll Transfer in the aggregate amount of \$306,901.00 for the fiscal year ending June 30, 2011.

**PUBLIC COMMENT**

All other speakers will be limited to a total of three continuous minutes, which cannot be delegated. These rules will be enforced but may be changed by appropriate City Council action.
